EMBLEM



3743rd Basic Military Training Squadron

331st Training Squadron emblem: Between and surmounting at their centers two white Grecian doric columns, edged and detailed gold brown, an Air Force blue lozenge within and quartered lozengy, one, two, one, by a narrow Air Force yellow border. First quarter, in chief, the colors, red, white, and blue, issuing from base and radiating throughout, second quarter, in dexter (right), a winged torch and third quarter, in sinister (left), the bead of Athena affrontee, wearing a breastplate and helmet, all Air Force yellow detailed gold brown, fourth guarter, in base, an Air Force yellow open book diminishing toward chief, pages white, all detailed gold brown. Emblem between two white scrolls edged Air Force yellow lower scroll inscribed with Air Force yellow capital letters shaded gold brown. SIGNIFICANCE: The emblem is symbolic of the squadron's history and mission. Against a background of blue that alludes to the sky, the aerospace theater of Air Force operations, the open book indicates the unit's mission, basic military indoctrination. The red, white and blue of our national colors refer to the trainees, from all parts of the United States, that the squadron provides to the many fields of service in the United States Air Force. The head of Athena, a Greek goddess, warlike in defending state and home and also embodying wisdom, reason, and purity, symbolizes the squadron's history as one of the first three basic training units for the newly established Women of the Air Force Corps in 1948. The winged torch of knowledge, symbol of learning or education, is emblematic of the Air Education and Training Command. The Doric columns signify the excellent support rendered by men and women in the Air Force in every assignment. The emblem bears the Air Force colors, golden yellow and ultramarine blue. BMT Commander Relieved of Command: In another shakeup caused by the ongoing investigation into sexual misconduct among Air Force military training instructors at JSBA-Lackland, Tex., the colonel in charge of basic military training operations there has been relieved of command, according to press reports. Col. Eric Axelbank, who oversees all training operations at San Antonio-Lackland "lost confidence" in the ability of Col. Glenn Palmer , BMT commander, "to maintain a safe and secure training environment for our newest airmen," reported the Los Angeles Times on Aug. 10, citing a 37th Training Wing spokeswoman. Axelbank commands the 37th TRW; Palmer had led the 737th Training Group since July 2011. Despite his removal, the spokeswoman made clear that "Palmer did not create the environment that resulted in the misconduct." The Air Force is investigating 15 former MTIs for alleged sexual misconduct with trainees dating back to fall 2009. Already court-martials have found three of them guilty and they have been sentenced. Back in June, Axelbank removed the commander of the 331st Training Squadron, the unit in which resided most of the MTIs accused of abuse. 2012
